GENERAL PROCUREMENT NOTICE

1. The Governments of the Republics of Zambia and Zimbabwe secured funding through loans and grants from the African Development Bank (AfDB), the Swedish Government and the World Bank for the financing of the Kariba Dam Rehabilitation Project (“**the Project**”), and intend to apply part of the proceeds towards payment for goods, works, related services and consulting services to be procured under the Project.
2. The Project includes the following components:
 - i. Spillway Refurbishment
 - ii. Dispute Resolution Board
3. Description of the goods, works and services to be procured under the International Competitive Bidding (ICB) procedures for the Project are as follows:
 - (i) **Goods and Non Consultancy Services (to be procured under a supply and installation contract)**
 - Dam-Spillway Refurbishment (Including all electro-mechanical and related civil works)
 - (ii) **Consultancy Services**
 - Dispute Resolution Board
4. Procurement of contracts financed by the African Development Bank (AfDB), the Swedish Government and the World Bank will be conducted through the procedures as specified in the World Bank’s [*Guidelines: Procurement under IBRD Loans and IDA Credits*](#) (January 2011 Revised July 2014), and is open to all eligible bidders as

defined in the guidelines. Consulting services will be selected in accordance with the World Bank's [*Guidelines: Selection and Employment of Consultants by World Bank Borrowers*](#) (January 2011 Revised July 2014).

Specific procurement notices for contracts under the World Bank's international competitive bidding (ICB) procedures and for contracts for consultancy services will be announced, as they become available, in [*UN Development Business, dgMarket*](#), Zambezi River Authority Website and local newspapers in Zambia and Zimbabwe.

Prequalification of suppliers and contractors will be required for the following contract;

Spillway Refurbishment: supply, installation and commissioning of a temporary cofferdam, new emergency gate, new maintenance stop beams, related civil works on the embedded parts, new gantry crane and related civil works (including new concrete beam for upstream rail) and electrical works for the mentioned equipment.
